- Outcome:** The presentations of the panel and a summary of interventions will be compiled and made available electronically and kept on record together with contributions to other commemorative events throughout the year.

Format: The moderated discussion will strive to achieve a great degree of interaction between the panellists and the participants. The list of speakers for the discussion will be established at the beginning of the panel and, as per established practice, statements by high-level dignitaries and groups will be moved to the beginning of the list. States and observers, including representatives of civil society, take the floor for a 2-minute intervention each, followed by responses from panellists. A total of two rounds of interventions from the floor will be followed by responses and remarks from the panellists. Interpretation will be provided in the six United Nations official languages (Arabic, Chinese, English, French, Russian and Spanish). A short video will be screened, presenting various achievements of the Council.

To ensure the interactive dimension of the panel, participants are invited to focus their interventions on asking questions to the panellists and/or sharing observations related to concrete aspects of the work of the Human Rights Council and its mechanisms, from the Council's sessions or the process leading to its establishment. Participants may wish to refer to the Council's role and effectiveness in generating norms and driving implementation on the ground for the benefit of rights holders. They may also wish to reflect on their national efforts and lessons learned in the implementation of Council resolutions, and recommendations of the Council's mechanisms. In highlighting the Council's achievements, participants may wish to share their views and experience about the Human Rights Council implementation of the mandate given to it by General Assembly resolution 60/251.

Background: The Human Rights Council was created by General Assembly resolution 60/251 of 15 March 2006 to strengthen the United Nations human rights machinery, with the aim of ensuring effective enjoyment by all of all human rights. The Council replaced the Commission on Human Rights, which had been a subsidiary organ of the Economic and Social Council. The establishment of the Council as a subsidiary organ of the General Assembly elevated human rights within the United Nations system. The tenth anniversary offers an important opportunity to underline and reiterate the commitment to the universal promotion and protection of the human rights of all, and to reflect on the achievements and challenges of the Human Rights Council.

Accessibility for persons with disabilities: In an effort to render the Human Rights Council more accessible to persons with disabilities and to promote their full participation in the work of the Council on an equal basis with others, the panel will be made accessible to persons with disabilities. During the debate, international sign interpretation and real-time captioning will be provided and webcasted. In Room XX, four seats are reserved for participants with disabilities in the last (seventh) row. Hearing loops are available for collection from the Accessibility Focal Point at the secretariat desk in Room XX.
